



ABSOLUTELY BREW COFFEE LLC

AFFILIATE PROGRAM TERMS & CONDITIONS

Effective Date: June 13, 2026

This Affiliate Program Terms & Conditions Agreement (the "Agreement") is legally entered into by and between **Absolutely Brew Coffee LLC** (the "Company") and the individual or entity enrolling as a participant in the Company's Affiliate Program (the "Affiliate"). By submitting an application or participating in the Absolutely Brew Coffee LLC Affiliate Program, the Affiliate hereby acknowledges, understands, and agrees to comply with and be legally bound by all terms, conditions, and corporate policies set forth herein.

SECTION 1: ELIGIBILITY & ENROLLMENT

1.1 Age Requirement: Participants must be at least eighteen (18) years of age at the time of enrollment to participate legally in the Affiliate Program.

1.2 Registration Accuracy: The Affiliate must provide complete, truthful, and accurate registration data throughout their enrollment with the Company.

1.3 Statutory Compliance: The Affiliate shall maintain complete ongoing compliance with all applicable local, state, and federal laws and regulations governing advertising and commercial activity.

SECTION 2: PROGRAM OVERVIEW & RELATIONSHIP STATUS

2.1 Product-Driven Nature: This Program is strictly a product-driven commercial network. Financial earnings are generated solely through verified coffee product sales and authorized consumer referrals.

2.2 Independent Contractor Status: Participation in this Program does not constitute an investment opportunity, employment partnership, joint venture, franchise, or corporate agency. No passive income, equity interest, or financial guarantees are provided or implied.

SECTION 3: CUSTOMER DISCOUNTS & COMMISSION STRUCTURE

3.1 Lifetime Customer Discount: Formally registered and qualified customers under an active Affiliate link shall receive a ten percent (10%) lifetime discount on qualifying product purchases.

3.2 Discount Policy Enforcement: Any perceived abuse, exploitation, or unauthorized distribution of referral links or discount mechanisms will result in the immediate investigation, suspension, or termination of the Affiliate account.

3.3 Tiered Commission Matrix: Base commission structures are calculated strictly on net sales volume, explicitly excluding sales taxes, shipping and handling fees, and product refunds or chargebacks. Commissions are distributed across three distinct relationship levels:

- **Level 1 (Direct Referrals):** Ten percent (10%) of net product sales.
- **Level 2:** Five percent (5%) of net product sales.
- **Level 3:** Two percent (2%) of net product sales.

SECTION 4: RANK SYSTEM, PERFORMANCE BONUSES, & PAYOUTS

4.1 Rank Advancement: Affiliate rank classifications are achieved systematically based on verified sales volume thresholds and verified downline team performance metrics.

4.2 Rank Status Bonuses: Achievement-based rank bonuses represent structural status eligibility incentives and do not alter, replace, or supersede the core base commission percentages.

4.3 Minimum Payout Threshold: Payouts are systematically processed on a monthly schedule, contingent upon the Affiliate reaching a minimum cumulative earnings balance of fifty dollars (\$50.00).

4.4 Withholding Rights: The Company reserves the unilateral right to withhold or forfeit payment distributions pending comprehensive review for potential system fraud, deceptive practices, or transactional chargebacks.

SECTION 5: PROHIBITED MARKETING ACTIVITIES & INCOME DISCLAIMERS

5.1 Deceptive Marketing Practices: Affiliates are strictly prohibited from misrepresenting potential income, executing deceptive or misleading advertising campaigns, deploying spam or unsolicited mass messages, or abusing corporate referral networks.

5.2 Income Disclaimer: Absolutely Brew Coffee LLC offers no direct or implied financial or income guarantees. Individual earnings depend entirely upon individual marketing effort, technical skill, and final sales performance.

5.3 Tax Liability: The Affiliate operates solely as an independent contractor and maintains exclusive personal responsibility for reporting all earned income and paying any applicable state, federal, or local self-employment taxes.

SECTION 6: TERMINATION & GOVERNING LAW

6.1 At-Will Termination: Either participating party may terminate this contractual arrangement at any time, with or without explicit cause, upon providing formal written notice to the other party.

6.2 Breach Forfeiture: Verified material violations of these terms, conditions, or standard corporate codes of conduct will result in immediate termination of account access and the complete forfeiture of any accrued, unpaid commissions.

6.3 Governing Law: This agreement, its structural interpretation, and any legal disputes arising directly or indirectly from it shall be governed by and construed in accordance with the laws of the **State of Michigan**.
