This document outlines the formalized commission metrics, rank milestones, and downline structures governing participant compensation under the Absolutely Brew Coffee LLC Affiliate Program. All payouts and calculations are managed strictly in accordance with the overarching terms, conditions, and anti-fraud protocols of the primary contract.

1. BASE COMMISSION STRUCTURE & INCENTIVES

Commissions are calculated dynamically based entirely on net product sales totals—meaning the raw product price after customer discounts are applied, explicitly excluding shipping costs, localized sales taxes, and returned item values.

Tiered Network Commission Breakdown:

Level 1 (Direct Sales):	10% Core Commission
Level 2 Downline:	5% Team Override
Level 3 Downline:	2% Team Override

** Incentive Baseline: Every client registration provides a default 10% discount off every qualifying product purchase.*

2. AFFILIATE RANK CLASSIFICATIONS & PERFORMANCE METRICS

Rank advancements recognize network growth, structural management depth, and verified sales performance targets. Bonuses associated with rank tier changes represent separate programmatic incentives and do not replace or diminish base tier payouts.
